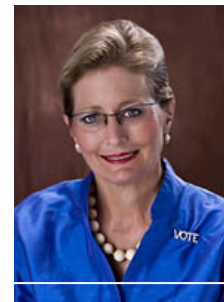

Deirdre Macnab, President of the League of Women Voters of Florida, has announced that the Sanibel MAL unit of the Florida LWV has met all requirements to be recognized as a local League.

The LWV state board, at their meeting on March 21, approved this action unanimously.

President Macnab said: "We are thrilled to welcome our new League of Women Voters on Sanibel Island. They have hit the ground running, helping inform the public on key issues such as coastal drilling and the important and often complex amendments that will be on the ballot in November 2010. The League of Women Voters works to encourage active and informed participation in government, and Sanibel Island will now have a dedicated force of volunteer League members working to bring an objective and broad perspective on important issues to Sanibel residents."

From the national LWV

Campaign Finance Reform

League President Mary G. Wilson sent a letter to the Senate urging them to update campaign finance laws in the wake of Citizens United. Congressional testimony on a recent ABC News-*Washington Post* poll showed that the League is not alone in this fight: 80 percent of Americans of both parties oppose the Court's decision.

EPA and Climate Change

The League sent a letter to the House of Representatives urging members to oppose legislation from Representatives Moran and Pomeroy that would overturn the EPA's scientific finding that global warming pollutants endanger public health.

From the state LWV

The LWV of Florida has set three priority issues for 2010:

Government: Promote an open government that is responsive to the people of the state.

Equitable Taxation: The League supports tax legislation which does not jeopardize local service, addresses infrastructure deficits, and removes unfair tax exemptions that affect governments' ability to serve citizens.

Redistricting Reform: The League supports single-member election districts that are equal in population, that provide access for minorities, are compact and, when possible, take local characteristics such as political and geographical boundaries into consideration.
